The student is expelled from the district until the end of the second semester. The student is to seek

psychological services, enroll and complete remainder of the school year in a community school in either Delano or Bakersfield. The student will be allowed to re-enroll in the Wasco Union High School District in the fall of 2006 upon the completion of the previous mentioned criteria.

Eric Lowe reported on the homecoming activities, activities for Wasco/Shafter week and the exchange rally and football game on Thursday. The upcoming powderpuff game will be held on Tuesday night. Reporting on the number of students who made the honor roll with above a 3.0 GPA, he stated the seniors had 77 students, the juniors had 63 students, the sophomores had 77 students and the freshmen had 121 students.

Mrs. McCray wanted to make a public apology for the theft that occurred during the Taft football game. We are doing a thorough investigation and will do everything possible to apprehend the individuals responsible. We are working on procedures and security to ensure that this will not happen again. She stated Mrs. Albrecht, Mr. Elwood and Mr. Lonza will be attending a NKVTC Advisory Committee meeting on Monday to further the communication between North Kern Vocational Training Center and Wasco High School on the vocational education program. She wanted to reiterate what had been said regarding homecoming. It was terrific and fun and great to see the students pull together to make that happen. She stated the enrollment for the district is 1614 with 1410 at Wasco High and 204 at Independence High. At this time last year the enrollment was 1520 for the district with 1279 at Wasco High and 241 at Independence High. Last month's enrollment was 1641 for the district with 1448 at Wasco High and 193 at Independence High.
