<u>Public Hearing on Sufficiency of Textbooks and Instructional Materials for 2007-08</u> School Year

A public hearing was convened to certify the district's compliance with Education Code §60119 concerning the sufficiency of textbooks and instructional materials for the 2007-08 school year. Mrs. McCray reported during the recent Williams visit we were found compliant in all areas regarding instructional materials. The hearing was closed.

Mr. Rios stated there was a lack of communication between Wasco High and Independence High regarding students eligible to attend athletic events on this campus.

Mrs. Wedel wanted to know what the decision of the Board is regarding the students eligible to attend events at the high school.

Mr. Fulwyler responded Mr. Lonza and Mr. Elwood would collaborate on the list of students eligible to attend the extra curricular activities and share the list with the campus supervisors in plenty of time before the start of the event.

Mrs. Desatoff reported she had attended her 40th class reunion and there is a wealth of resources of success stories that could be brought as speakers for career day, college day or where are they now. Everyone that gave a speech talked about how Wasco High had changed their life, and how it is a family.
