VI. Public Comments

Mr. Braun shared that the time allotted to any individual speaker is three (3) minutes. When numerous individuals wish to address the same issue, time will be limited to ten (10) minutes for the subject area. In case of numerous requests to address the same item, the Board President may select representatives to speak on each side of the item. He also reminded members of the audience to please refrain from making comments or asking questions beyond the public comment opportunity.

Mrs. Sandra Fisher addressed the Board and referred to the Minutes from the August Board Meeting regarding Item #10 under Discussion and Action. She asked the Board if this contract is in addition to Mr. Anthony Leonis.

Mrs. McCray shared that Mr. Leonis is our Labor Consultant. School Law Consultants will assist the Districts with the unification process.

- 1. Daniel Cisneros, Student Board Representative reported to the Board that the Back to School Night was great and the attendance was larger than it has been in the past. - 2. Mr. Fulwyler reported on behalf of the North Kern Vocational Training Center. He shared that there was a early meeting last month and that there was nothing to report.

3. Mrs. McCray then shared with the Board that the injured cheerleader was released on Friday afternoon. She commended the students and Staff for their great work during the incident. Mrs. McCray also reported on another student and Rose Queen Candidate who was complaining of abdominal pain. The doctor decided there was some swelling of the appendix and decided to remove the appendix. Upon removal it was diagnosed through a biopsy that cancer was present and was isolate to the appendix. Mrs. McCray thanked everyone for keeping these young ladies in their prayers.

Mrs. McCray then reported that the visit with Mrs. Linda Resnick went very well and she has an interest in Vocational Education. Mrs. Resnick was provided a tour of the North Kern Vocational Training Center facility and provided information regarding the program from Mr. Gary Garcia.

Mrs. McCray presented awards to Mr. Jesse Acebedo and Mr. Wayne Wallace on behalf of Kern County Superintendent of School in recognition of their Board Member Service

Mrs. McCray then introduced Mrs. Rhonda Jones who shared an update on the Relay for Life Event. Mrs. Jones shared that \$87,000 was raised and over 100 survivors were in attendance.
